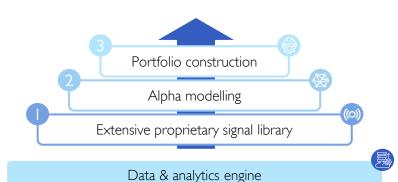
# Strategy Description

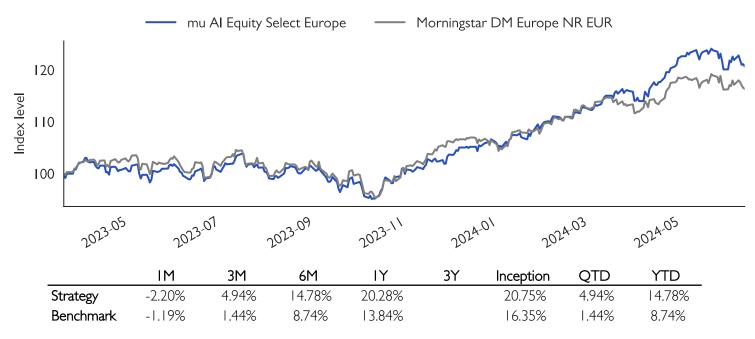

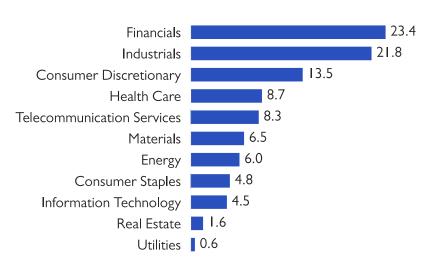
