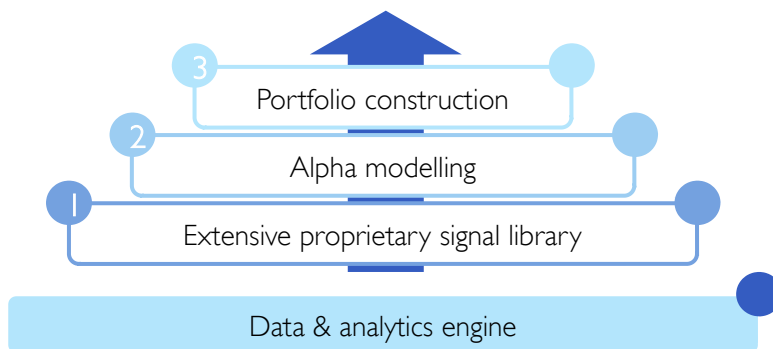
Strategy Description

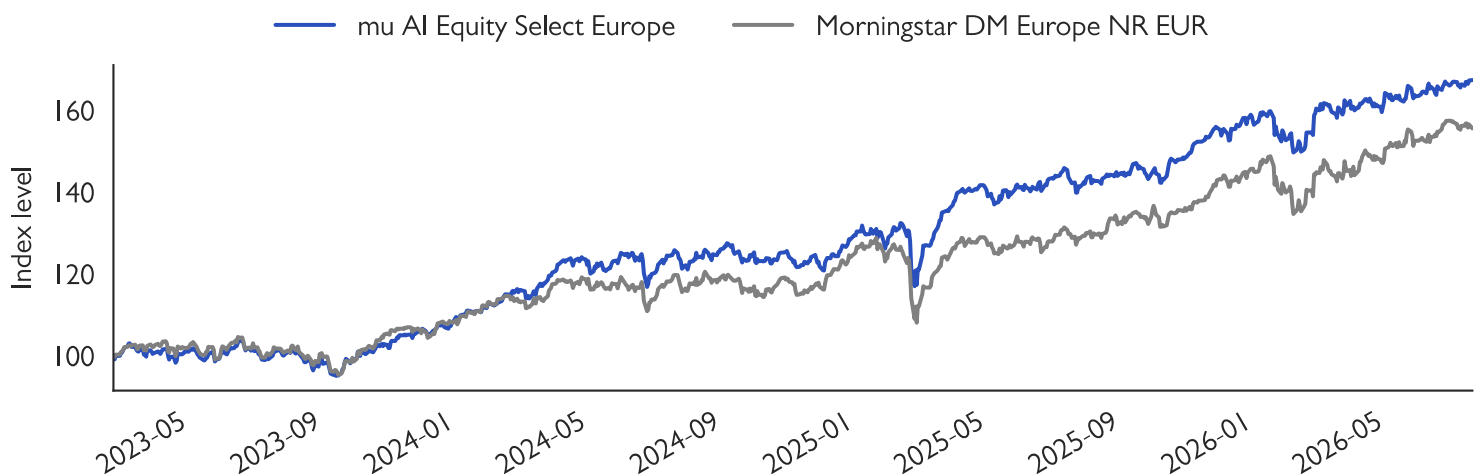

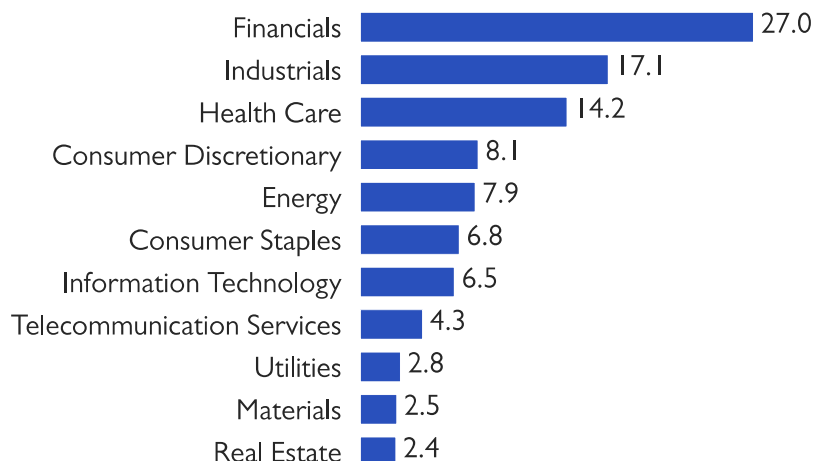

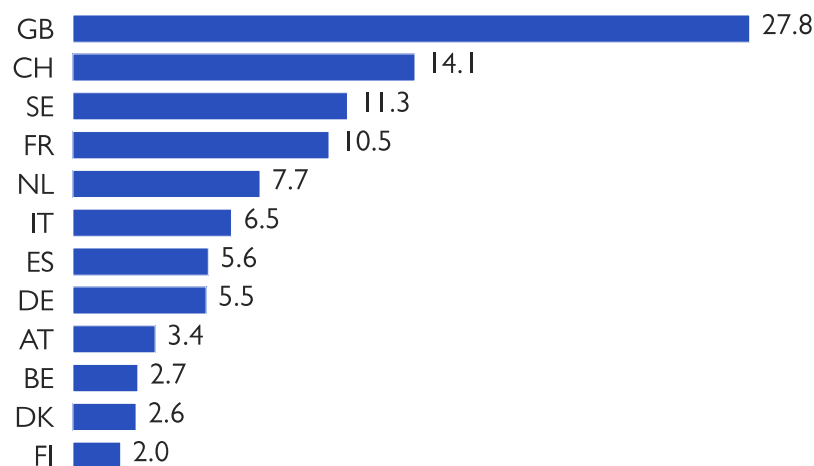
